

## Ramsey County Case Timeline

August 12, 2024

Plaintiff initiates a formal phone report to Ramsey County Children's Services regarding Respondent Madeline Sally Lee's online conduct. The report cites concern over Respondent's public statements and content suggesting her minor daughter was being used as a lure in foreign romance scams, posing a potential danger to the child's safety. Plaintiff provides her legal name and correct phone number during this report. Plaintiff believes this report—made in good faith and through official channels—was later disclosed to Respondent by someone within the court or child services system, triggering the retaliatory Harassment Restraining Order petition filed weeks later.

August 29, 2024

NH Sheriff's Office files non-service affidavit.

September 5, 2024

First harassment hearing is held, I am not notified. I do not attend.

September 28, 2024

AZ Sheriff's Office files non-service affidavit.

October 3, 2024

Second harassment hearing is held, I am not notified. I do not attend.

November 8, 2024

Third harassment hearing is held, I am not notified. I do not attend.

November 12, 2024

First class letter returned undeliverable.

December 9, 2024

Certified letter returned undeliverable.

December 12, 2024

Fourth harassment hearing held, I am not notified. I do not attend. HRO is granted without attendance or service. Court later falsely claims this as date of service.

February 4, 2025

Deputy Loya calls me, fails to disclose HRO, later lies in report. Incorrect phone number confirmed.

February 26, 2025

I am served by Maricopa Deputy who expresses confusion. Days later, mail from Madeline arrives: address leak confirmed.

March 6, 2025

I file a civil suit against Madeline. \$85 paid. Never docketed. On the same day, I also filed two Harassment Restraining Orders (HROs) against Madeline—one for myself and one for my husband. His HRO was processed immediately. A hearing was granted, and after Madeline's request for mediation, an informal court order was issued. My HRO hearing was never scheduled. No action has been taken by the court as of this writing.

March 8, 2025

Motion to Rescind HRO filed by mail, dropped off in a blue letterbox using nonmachinable stamp -within valid 10-day window.

March 18, 2025

Received deficiency notice demanding payment of \$300 or fee waiver application.

April 11, 2025

Fee waiver approved at 8:00 AM, Motion to Rescind HRO denied at 3:00 PM, citing December service date. Court acknowledges standing but uses false timeline to deny legal remedy on same day.

April 17, 2025

Hearing for Motion to Vacate granted, scheduled for May 23, 2025. Approximately nine months after the order was granted, and despite multiple requests to hear the Motion sooner with proof of ongoing death

threats based on the issuance of this order.

April 23, 2025

Madeline admits in her requested hearing to vacate my Injunction Against Harassment that court she gave my info to Sumit Sinha (source of threats, harassment, and physical letters).

April 30, 2025

I receive part of the previously submitted comprehensive records and data request, proving that I was never served.

May 4, 2025

I finalize and file federal complaint, prepare for MDHR interview.

May 7, 2025

MDHR interview scheduled re: ADA denial, retaliation, procedural obstruction.
