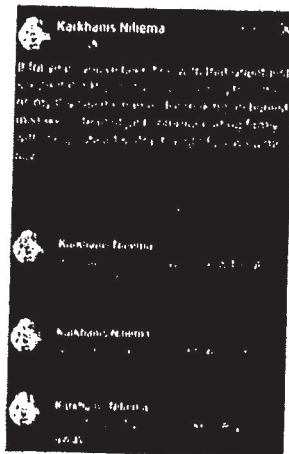


Illustration of impact of false allegations

She has not responded to being summoned to a hearing and the only thing that will stop her is ~~if~~ it she is formally sanctioned.

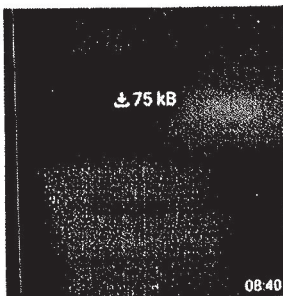
