On 02/03/2025 at approximately 0835 hours I, Deputy Loya, responded to the lobby of 1411 KIRKWOLD DRIVE, ARDEN HILLS, for a party who has a Harassment Restraining Order in place where the respondent is violating the order. The party was later identified as MADELINE SALLY MACHLA LEE (DOB: [REDACTED]).

Upon arrival, I made contact with LEE who was sitting down in our lobby. I had asked her what had occurred to which she responded with the following:

- LEE has a HRO against KELLYE STRICKLAND (DOB: [REDACTED]). HRO #62-HR-CV-24-963.
- LEE had been getting messages from who she believes is STRICKLAND.
- LEE knows STRICKLAND from social media.
- LEE had a court hearing via Zoom which STRICKLAND did not show up.
- STRICKLAND currently resides in Maricopa County in Arizona.
- LEE was informed by Maricopa County that the HRO has been mailed to STRICKLAND since they were not able to make contact.
- LEE had been a victim of sexual assault by a male party that STRICKLAND has contact as well.
- LEE has received messages from STRICKLAND that goes by "OnionAnne Sundar" online.
- LEE's mother has also been contacted by STRICKLAND from a 603-856-3542 phone number via text and phone calls.
- LEE had made a prior report with another Deputy in regards of the same issue, refer to case #25005037.

After I spoke to MADELINE, I proceeded to contact her mother, DONNELL MARIE LEE (DOB: [REDACTED]), who was also contacted by STRICKLAND via phone. I made contact with DONNELL to which she informed me of the following:

- STRICKLAND had made contact via messenger a couple months ago.
- DONNELL had received a message on 02/02/2025 from from possibly STRICKLAND.
- DONNELL does not know details of the harassment between STRICKLAND and MADELINE.
- DONNELL is unsure who is really messaging since she believes it could be from people in India.

After I spoke with DONNELL, I attempted to contact the phone number that would be STRICKLAND'S, 608-856-3542. I made contact with KELLYE STRICKLAND (DOB: [REDACTED]). She informed me of the following:

- She has been getting messages from MADELINE.
- STRICKLAND believes MADELINE is screen shotting messages with STRICKLANDS name and photo shopping them.
- STRICKLAND has not received any restraining orders from MADELINE.
- STRICKLAND only knows MADELINE from Facebook.
- STRICKLAND believed MADELINE had been one of her friends.
- MADELINE had added several friends from STRICKLAND's Facebook account.
- STRICKLAND has not used Facebook for a while. She uses the pseudo name of "OnionAnne."
- STRICKLAND has been contacted by New Hampshire Police in regards of a restraining order that MADELINE had in place.
- STRICKLAND has never made contact with DONNELL nor knows who she is.

- STRICKLAND's lawyer is Jeremy Huss but has not being in contact with him.
- STRICKLAND contacted Tempe Police to report this incident to which they did not provide a case number.
- STRICKLAND made a report through the FBI which is #183120879.

During this interaction with STRICKLAND, she sounded in distressed, upset, and appeared to be crying over the phone. It appeared that MADELINE has been stressing STRICKLAND where she cannot live life normally. It also appears that in this case its possible that STRICKLAND is the victim.

There are forms that were attached to this report that show a Ramsey County HRO, #62-HR-CV-24-963, which it stated STRICKLANDS's birthday as [REDACTED], which is not correct. There is also a phone number that is attached to this form for the Court's administration staff that is not correct. Also to be noticed, there were dates on the HRO that stated being revised in 2021 when the order had been placed on December 2024.

Screen shots of STRICKLAND's messages to MADELINE had been attached to this report as well, along with a typed up report about STRICKLAND's harassment and how it all began.

I provided STRICKLAND a copy of the report and advised her to contact the Court Administrator to possibly clear the Harassment Restraining Order since there is not consistent proof that STRICKLAND is indeed harassing MADELINE. I also advised STRICKLAND to contact her credit accounts to advised them on potential credit accounts being open without her consent along with contacting her attorney to be up to date with the current issue.
