I, Madeline Lee, affirm under penalty of perjury that the following is a true and accurate amended statement addressing the ongoing harassment, retaliation, and threats committed by the defendant, Kellye Strickland, also known by aliases "Onion Madder," "OnionAnne Sundar," and others. This statement incorporates new material developments and introduces Exhibits A through V to provide comprehensive documentation of her sustained campaign against me.

Background and Initial Harassment (Exhibits A-B):

From December 2023 to May 2024, I was in a relationship with Kshitij Dhyani of New Delhi, India. After enduring abusive behavior and public defamation by Kshitij, I pursued legal action with the support of attorney Fidel Sebastian. In May 2024, Kellye Strickland publicly admitted to encouraging Kshitij to file false CPS reports against me (Exhibit A), resulting in two investigations in June and July 2024, both dismissed (Exhibit B).

Escalating Defamation and Third-Party Harassment (Exhibits C-J):

By July 2024, Kellye had begun messaging over a dozen of my personal and professional contacts (Exhibit C), sent abusive WhatsApp messages (Exhibit D), and threatened to interfere with my employment (Exhibit E). She published threats on Reddit (Exhibit F) and messaged my parents false accusations of abuse (Exhibit G). On August 16, she sent racially targeted threats to my attorney and threatened to bankrupt me through retaliatory legal action (Exhibit H). On August 17, she posted my private information online, leading to real-world harassment and a Craigslist ad that forced me to change my phone number (Exhibit I). The next day, she sent a falsified cease and desist letter using a known false address (Exhibit J).

Broad Retaliation and Continued Contact (Exhibits K-M):

She continued contacting over 150 individuals with false statements and threats (Exhibit K). By August 29, 2024, she publicly admitted she knew about the harassment restraining order, contradicting her legal filings (Exhibit L). In February 2025, she renewed harassment through false claims of identity theft and a second threatening message to my mother (Exhibit M).

Misrepresentation, Racism, and Physical Threats (Exhibits N–P):

Around February 25, Kellye falsely claimed Sumit Sinha's message to her was orchestrated by me (Exhibit N), followed by a racist tirade and defamatory rape accusation against my attorney (Exhibit O). In February, 2025, she threatened to travel to Minneapolis to physically assault me (Exhibit P).

Legal Retaliation and Post-Hearing Misconduct (Exhibits Q-S):

After the Arizona injunction was dismissed on April 23, 2025, Kellye resumed defamatory posts and threatened Sumit Sinha (Exhibit Q). On April 25 and 30, she escalated her attacks to include accusations of child abuse, sexual deviance, and threats to my family and employment (Exhibit R). She also attempted to revoke my right to a remote hearing, a transparent abuse of process denied by the court (Exhibit S).

Proven Falsehoods and Audio Evidence (Exhibit T):

Kellye claimed a threatening voicemail to my mother was fabricated. A screen recording clearly identifies her voice and number, disproving this (Exhibit T).

Website Doxxing Campaigns (Exhibit U):

On May 5 2025, Kellye began promoting her websites — https://onionmadder.com and https://onionmadder.xyz containing violent and defamatory statements about me, individuals named in my legal filings, and threatening litigation against over 110 public employees. These pages include public threats, doxxing, and conspiratorial accusations against witnesses, friends, and my family (Exhibit U).

Facebook Amplification and Threats (Exhibit V):

On May 7, 2025, Kellye reposted content from her website to Facebook, doubling down on threats against people I named in my testimony. She falsely claimed that the men listed were my victims, disparaged and misidentified them based on racial and religious assumptions, and misrepresented my statements during the April 23 hearing (Exhibit V).

Conclusion:

Kellye Strickland's harassment has been consistent, retaliatory, and well-documented. From defamation and racist abuse to falsified legal threats, digital doxxing, and threats of physical violence, she has violated the terms and intent of the harassment restraining order granted on December 12, 2024 and she has clearly stated her intention to continue to escalate her harassment and campaign of defamation in perpetuity. Her Motion to Vacate lacks all credibility and is contradicted by overwhelming evidence.

I respectfully request that the court deny her motion and uphold the current protective order.
